Terms & Conditions

This foaling contract is made and entered into on this _____ day of _____, 20____, by and between Chasing the Sun and _____, "owners" of mare name is _____ and Registration number is _____.

It is agreed between both parties that the above listed mare will be will be foaled out at Chasing the Sun. For and in consideration of the agreements hereinafter set forth, the "Owner" and Chasing the Sun agree as follows:

1. "Owner agrees to pay a one time, non-refundable foaling fee of \$300.00 in addition to regular mare care and breeding fees. The \$300.00 foaling fee includes 24 hour monitoring, foaling and aftercare of the mare and foal, and exam for mare and foal. Any additional medical charges can and may occur at the owner's expense.

2. Owner agrees that Chasing the Sun and their employees are not liable for the death, sickness, and/or accident including consequential damages caused to the mare and foal.
3. All other expenses, including board, veterinary expenses, farrier fees, etc. will be due and payable upon receipt of monthly statement. All fees shall be paid in full prior to the mare's departure from the farm.
4. Mares must have proof of current negative coggins and be current on all vaccines. If the mare arrives without proof of a negative coggins and vaccination dates the mare will be tested and vaccinated upon arrival at the mare owners' expense by our veterinarian.
5. EVA Requirements: all horses transported to Chasing the Sun must have documentation of a negative EVA (Equine Viral Arteritis) test within thirty days of arrival or documentation of an EVA an EVA Vaccination from your veterinarian a minimum of thirty days prior to arrival.
6. A copy of the mare's registration papers front and back must be returned with this contract.
7. It is the responsibility of the mare owner to carry full coverage insurance on the mare and foal if it is their desire to do so. Chasing the Sun will not have insurance coverage for individual mares, foals, or stallions on the farm.
8. If at any time, Chasing the Sun determines, in its sole judgment and discretion, the mare or foal needs immediate medical attention, Mare Owner agrees to leave this decision at the discretion of the local on call veterinarian if the owner cannot be reached. Chasing the Sun will make every effort available to contact Mare Owner in a timely fashion, however the best interest of the mare and foal will prioritize.
9. Mare owner agrees to pay all charges in full that are payable to Chasing the Sun, before removing mare and foal from the facility.
10. Mare Owner must give Chasing the Sun a minimum of 3 days notice before the removal of the mare and foal, to allow for preparation of paperwork. The mare owner is responsible for making arrangements for the mare and foal during regular business hours.
11. Mare and foal will not be released if insufficient notice is given or the bill is not paid in full prior to departure.
12. This contract is not transferable. If the mare is sold, all unpaid fees become immediately due and payable and no refunds will be made.
